WAIVER AND RELEASE OF LIABILITY

In consideration of Wasilla SplatterHouse furnishing services and /or equipment to enable me to participate in paintball games, I agree as follows:

I fully understand and acknowledge that; (a) risks and dangers exist in my use of Paintball equipment and my participation in Paintball activities; (b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Wasilla SplatterHouse ; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of Wasilla SplatterHouse, or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Wasilla SplatterHouse and it's owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Paintball equipment or my participation in Paintball activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of Wasilla SplatterHouse.

MEDICAL PERMISSION AUTHORIZATION

If the participant is of minority age, the undersigned parent or guardian hereby gives permission for Wasilla SplatterHouse to authorize emergency medical treatment as may be deemed necessary for the child named below while participating in paintball games from this date through 12/31/10.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE WASILLA SPLATTERHOUSE FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.

I further agree that I will adhere to all Safety Rules.

I understand I may use only Field Paint, and bringing in outside paint or failure to abide by all posted rules is grounds for immediate expulsion from the facility with no refund.

I further agree that I have read, and will adhere to all Safety Rules, (posted on the wall) and rules of the Wasilla SplatterHouse Facility.

EQUIPMENT RENTAL AGREEMENT FORM

I, the undersigned, am renting the equipment listed on this sheet AS IS, in order to participate in paintball games at Wasilla SplatterHouse. I understand that while the equipment is in my possession, I AM SOLELY RESPONSIBLE FOR THE EQUIPMENT. I agree that any equipment lost, broken, stolen or damaged in any way or manner at any time, while signed out, rented or loaned to me, for or in my name will be immediately paid for in cash or with a credit card at full retail value, as soon as the item is lost, stolen, broken or damaged. As a sign of good faith I hereby promise to take care of all rented equipment and to use rented equipment ONLY in a manner consistent in which it was intended for. I promise to return all rented equipment in good or same condition prior to leaving this facility. I am providing Wasilla SplatterHouse a valid credit card, which Wasilla SplatterHouse may retain as long as necessary until ALL INDIVIDUAL OR GROUP EQUIPMENT IS RETURNED AND ACCOUNTED FOR. I further authorize Wasilla SplatterHouse to charge my credit card for the full retail value of the equipment lost, broken, stolen or damaged in any way, plus other fees incurred such as, but not limited to: shipping, handling, phone charges, etc. All participants are issued a marker with ball hopper and air tank, face-mask/goggles, and barrel cover or sock. I agree to return all equipment issued to me to the same location I picked it up at prior to or upon the expiration of my field pass on the same date issued.

Wasilla SplatterHouse Rules

- 1. ANSI OR ASTM APPROVED GOGGLE SYSTEMS MUST BE WORN AT ALL TIMES.** Goggle Systems include face mask, ear protection, and eye goggles. Players must start wearing goggle system whenever they enter the staging area, and always while on the playing field. At no time will a player be allowed to break the seal of the goggle system from the face while on the playing field.
- 2. AVOID SHOOTING AT THE NECK OR HEAD. NO BLIND SHOOTING.** Players should check their target before firing. Players should avoid head Shots. Players should never shoot at the Back of the Head or Neck intentionally.
- 3. BARREL SOCKS OR PLUGS ARE REQUIRED IN ALL SAFE AREAS.** Players may never discharge their guns anywhere with the exception of the chronograph station or the playing field their game is being held on.
- 4. BARREL SOCKS ARE PREFERRED OVER BARREL PLUGS.** All players should use barrel socks at Wasilla SplatterHouse.
- 5. ALL PAINTBALL GUNS MUST BE TRANSPORTED TO THE FIELD IN A CLOSED CONTAINER SUCH AS A GUN CASE OR BAG.** This includes the parking lot. Players may never remove their barrel socks or plugs unless at the chronograph station or when told to do so by the referee when entering the field. Only devices manufactured as barrel socks or plugs may be used. Squeegees and other such items may not be used.
- 6. MUZZEL VELOCITY IS LIMITED TO A MAXIMUM OF 260 fps indoors, 290 fps outdoors.** If you are in excessive violation of this you will be asked to leave the Park.
- 7. NO CLIMBING OF, OR OVER STRUCTURES.**
- 8. NO PHYSICAL CONTACT.** A player may never touch another player or his equipment.
- 9. NO UNAUTHORIZED EQUIPMENT.** Players are not allowed to bring onto the playing field any equipment deemed to be unsafe or not appropriate by the field operator. All guns are required to have a factory trigger guard. Players are not allowed to use any gun that has an enhanced trigger mode. All guns must be actual semi-auto. One complete trigger pull for each round fired. Players are not allowed to wear metal cleats. Players are never allowed to bring onto the field knives of any size, tools of any sort, machetes, axes, hatchets, paint grenades, paint mines, multiple paintball launchers, pyrotechnics, smoke grenades, or any type of firearms or explosives.
- 10. AVOID FIELD HAZARDS.** Players should avoid all obvious hazards. Players should report any hazard to the field operator.
- 11. PLAYERS MAY NOT ALTER THE PLAYING FIELD.** Players may never alter or move any obstacles on the field.
- 12. NO ALCOHOL IS ALLOWED**

13. SMOKING IS NOT ALLOWED INSIDE THE BUILDING.

14. NO VERBAL ABUSE.

No profanity, name-calling or slurs against anyone's race, color, religion, or national origin will be tolerated.

15. GASED UP MARKERS ARE ONLY ALLOWED ON THE FIELD.

Turn air supply off if you are equipped. Please make sure you degas your marker before leaving the field.

16. DO NOT ATTEMPT TO REMOVE COMPONENTS FROM RENTAL EQUIPMENT. Players are never allowed to remove any parts or components from the rental equipment. If you have a problem with your rental equipment return it to the rental desk for the staff to repair.

17. THROWING PAINTBALLS AND/OR POURING THEM ON THE GROUND IS PROHIBITED.

Players are not allowed to throw paintballs anywhere in the park. No one is allowed to pour paintballs on the ground. Paintballs should be disposed of in trash containers.

18. REFS DECISIONS ARE FINAL. Players are not allowed to argue with any ref. Refs will be happy to discuss any call after the game.

19. WIPING PAINT OFF IN A GAME IS CHEATING. If you wipe you will be asked to leave.

20. NO MALICIOUS ACTS. Shooting Lights, Ceilings, Windows or throwing your marker are Malicious Acts. If you do this you will be asked to leave. You will be held financially responsible for any damages you cause.

21. PROTECTIVE CLOTHING REQUIRED. Shorts, t-shirts, tank tops, and sandals will not be considered sufficient protective clothing. Long sleeves, long pants and tennis type shoes are required.

22. NO MODIFICATIONS TO PAINTBALL MARKERS WILL BE DONE ON THE FIELD. If you need to do modifications or repairs to your marker it will be done off the field with no air or gas attached.

23. WASILLA SPLATTERHOUSE WILL NOT BE HELD RESPONSIBLE FOR PERSONAL PROPERTY. Please lock your vehicle and don't leave any property unattended.

ANY VIOLATION OF THE SAFETY RULES WILL RESULT IN THE OFFENDING GUEST BEING REMOVED FROM PLAY FOR THE REMAINDER OF THE DAY. NO REFUNDS WILL BE GIVEN!

ALL PAINTBALLS USED IN THE WASILLA SPLATTERHOUSE MUST BE PURCHASED FROM WASILLA SPLATTERHOUSE, FIELD PAINT ONLY. NO CARRYON PAINT IS ALLOWED.

Note: Wasilla SplatterHouse is Alcohol Free. Paintball and Alcohol do not mix. So don't bring any Alcohol to Wasilla SplatterHouse. Violators will be asked to leave immediately.
